## SECTION 4 FIRST AID MEASURES

**EYE EXPOSURE:** Immediately flush the eyes with copious amounts of water for at least 15 minutes. Assure flushing under eyelids. A victim may need assistance in keeping their eyelids open. Get immediate competent medical attention.

**PERSONAL PRECAUTIONS:** Wear all appropriate equipment when using this material. Ensure adequate ventilation. Avoid the formation of dust. Avoid breathing vapors, mist, gas, or dust. Acts as an oxidizing agent on organic materials such as wood, paper, and fats – Keep away from combustible materials

**ENVIRONMENTAL PRECAUTIONS:** Prevent spillage from entering drains. Any release to the environment may be subject to federal/national or local reporting requirements.

**METHODS AND MATERIALS FOR CONTAINMENT AND CLEANING UP:** Small spills can be mixed with vermiculite or sodium carbonate and swept up.

**PRECAUTIONS FOR SAFE HANDLING:** Wear appropriate personal protective equipment. Avoid contact with skin and eyes. Use with adequate ventilation. Wash thoroughly after using. Keep container closed when not in use. Avoid formation of dusts and aerosols. Substance can reduce the ignition temperature of flammable substances. Keep away from heat and sources of ignition – No smoking.

**CONDITIONS FOR SAFE STORAGE:** Store material in a tightly sealed container. Keep away from heat and direct sunlight. Store away from flammable substance, reducing agents, and organic materials. Store in a cool, dry area.
