## SECTION 4 FIRST AID MEASURES

**CONDITIONS FOR SAFE STORAGE:** Store in cool, dry, and well-ventilated area. Hygroscopic. Store away from flammable substances, reducing agents, organic materials, metal powders, water, and moisture. Store under dry inert gas.
